# LLB Group relaunches LLB Quotes market information platform

**Vaduz, 6 June 2016. The popular market information platform of the LLB Group, LLB Quotes, is being relaunched with a new design, expanded content, and additional functions.**

LLB Quotes ([www.llb.li/quotes](http://www.llb.li/quotes)) is the generally accessible market information platform of the Liechtensteinische Landesbank. The comprehensive range of data and information is now provided for all smartphones, tablets, and computers. The uniform, attractive, and functional "responsive design" is independent of the operating system used.

In terms of content, LLB Quotes offers detailed market data on equities, bonds, and currencies, up-to-date market overviews of the most important exchanges, in-depth reports and news from the AWP news agency, specific information on individual securities, and comparison data including information on LLB funds. The functional additions include customisation options, a currency calculator, the possibility of defining favourites, and a "limit minder", which provides information by text message or e-mail about price developments. The display and use of charts and figures has been optimised for mobile devices in accordance with the latest standards.

Kurt Mäder, who as Group COO is responsible for the LLB Group's digitalisation initiatives, says: "There are few banks that make market information of such breadth and depth freely available to anyone interested. With LLB Quotes, we are for the first time presenting a completely device- and operating-system-independent platform to users. As part of our digitalisation strategy, we are implementing this approach consistently throughout the LLB Group."

The new version of LLB Quotes is available on the internet at [www.llb.li/quotes](http://www.llb.li/quotes) in German and English, replacing the previous iOS app as well. Users can register for customised services with their existing personal data. New registration is free of charge.
